Vide this common order, aforementioned 17 contempt petitions shall disposed of.

Learned State counsel has placed on record copy of the order dated 14.12.2020 passed in LPA-315-2020, vide which it was directed that the contempt Court will consider adjourning the case beyond the date fixed. In the subsequent order dated 16.02.2021, it was further directed that till the next date of hearing, payment of retiral benefits equal to the element of alleged embezzlement amount forming the basis of the suit for recovery shall remain stayed.

Learned counsel for the petitioner(s) submit that even some of the writ petitioners have filed LPAs with regard to some portion of the judgment.

In view of the above, all these petitions are rendered as infructuous.

Liberty is granted to the petitioner(s) to move an application for revival, if so advised.
