1. This is a second petition filed under Section 439 of the Code of Criminal Procedure for grant of regular bail to the petitioner in FIR No.118 dated 24.02.2022, registered under Section 22(c) & 29 of the Narcotic Drugs & Psychotropic Substances Act, 1985, at Police Station Saran, District Faridabad.

2. On 04.05.2023, this Court was pleased to pass the following order: -

3. In pursuance of the said order, status report by way of an affidavit has been filed by Mahesh Kumar, HPS, Assistant Commissioner

of Police, Crime Faridabad, on behalf of the respondent-State and the medical report has been annexed as Annexure R-1, which is reproduced herein below: -

**“MEDICAL REPORT BY THE MEDICAL
OFFICER OF DISTRICT JAIL FARIDABAD**

**REGARDING UNDERTRIAL PRISONER MR. SUNIL @
PAPPU S/O MR.SURENDER (UT-1133/2022)**

1. *This is regarding undertrial prisoner Sunil @ Pappu age 39/M. patient came in District Prison Faridabad on dated 28/02/2022 and at the time of admission in jail, as per medical protocol medical examination was done by Medical Officer of District Prison Faridabad and in examination patient stated that he is injectable drug abuser from last 2.5 years.*
2. *Patient was Hepatitis-B, Hepatitis-C and HIV Positive in 2022. he has completed treatment for Hepatitis-B and Hepatitis-C already.*
3. *As patient is a known case of HIV, he is under anti retroviral therapy for HIV which we are providing to the patient on regular basis in supervision of jail medical staff.*
4. *On dated 16/05/2023 morning, he again examined by medical officer on duty on examination patient is conscious and oriented to time, place and person and complain of genralised weakness.*
5. *At present condition of patient is stable and he is already under treatment for HIV in jail and getting his Art treatment regularly.*

4. A perusal of the said report would show that the treatment for Hepatitis-B has been completed and the petitioner has also been treated for HIV.

5. Learned counsel for the petitioner has submitted that in view of the above-said report, the petitioner seeks to withdraw the present

petition, at this stage.

6. In view of the statement made by learned counsel for the petitioner, the present petition is dismissed as withdrawn, at this stage.
