The instant petition has been filed under Articles 226/227 of the Constitution of India for the issuance of a writ in the nature of mandamus directing the respondents to release the due payment of Rs. 14,20,630/- qua the works executed by the petitioner alongwith interest @ 12% per annum.

Learned counsel appearing on behalf of the petitioner contends that the petitioner was allotted work of Supply of Labour and material for Remodeling/Renovation of Ponds (Narega Works) in villages Hakimpur and Abdulapur in District Malerkotla. The petitioner has successfully completed the aforesaid work but the due payment of these works has not been released

to the petitioner. The details of the said works is mentioned at Para No. 2 of the writ petition.

It is contended that the bill with respect to the aforesaid work and various representations have already been sent by the petitioner to the respondent-authorities. Recently a representation dated 18.04.2023 (Annexure P-3) has been sent by the petitioner to the respondent No.4-the Executive Engineer, Panchayati Raj Public Works Division, Sangrur for release of due payment.

Learned counsel appearing on behalf of the petitioner contends that he would be satisfied at this juncture in case the respondent No.4-the Executive Engineer, Panchayati Raj Public Works Division, Sangrur is directed to look into the representation dated 18.04.2023 (Annexure P-3) and to pass a reasoned and speaking order thereupon in a time bound manner.

Notice of motion.

Mr. Saurav Verma, Addl. A.G. Punjab appears and accepts notice on behalf of respondents and has no objection in the event such prayer of the petitioner as aforesaid is accepted.

Accordingly, the present petition is disposed of with consent and without commenting on the merits of the claim, with a direction to respondent No.4-the Executive Engineer, Panchayati Raj Public Works Division, Sangrur to examine the grievance espoused by the petitioner in the representation dated 18.04.2023 (Annexure P-3) and to pass a reasoned and speaking order thereupon within a period of 03 months of the receipt of certified copy of this order after affording an opportunity of hearing to the respective parties.

Needless to mention that in the event any amount is found payable, the same shall be released forthwith and preferably within a period of 03 months of such a decision being taken by the respondent-authorities.

The petition is accordingly disposed of.
