Hence the permission be kindly granted to the petitioners/applicants to withdraw the pending contempt petition by way of allowing present Civil Misc. Application as per its prayer clause.”

Applicant-petitioner No.1 – Sarabjit Singh and respondents No.1 and 4, namely, Kuldeep Singh and Surinder Singh, respectively, are present in Court. They along with their counsel have affirmed the compromise.

In view of the above, present application is allowed and COCP is permitted to be withdrawn.
