The present petition has been filed for quashing of FIR No.0001 dated 25.03.2022 under Sections 406, 420, 120-B IPC and Section 3 of the Punjab Travel Professionals (Regulation) Act, 2014 registered at P.S. NRI, District SBS Nagar and all other consequential proceedings arising therefrom, on the basis of compromise dated 16.02.2023 (Annexure P-2) entered into between the parties.

Vide order dated 26.05.2023, this Court had directed the parties to appear before Illaqa Magistrate for getting their statements recorded in terms of certain parameters given in the aforesaid order dated 26.05.2023 with regard to the compromise dated 16.02.2023 (Annexure P-2).

In terms of the order dated 26.05.2023 passed by this Court parties have appeared before the court of Ms. Monica Chauhan, Judicial

Magistrate Ist Class, Shaheed Bhagat Singh Nagar and as per report dated 13.09.2023 submitted to this Court, both the parties have got recorded their respective statements in Court.

Perusal of the aforesaid report would show that the parties have effected a genuine compromise without there being any pressure, coercion or undue influence. In view of the compromise there is a remote possibility of the complainant coming forward to support the prosecution case. The powers under Section 482 Cr.PC can be exercised in such like situation in order to prevent unnecessary vagaries of criminal trial to be faced by the parties, when there are remote chances of conviction of the accused. The compromise in question is found to be fully in consonance with the direction issued by the Court in *Kulwinder Singh & Ors. Vs. State of Punjab 2007(3) RCR (Criminal) 1052* and *Gian Singh Vs. State of Punjab & Anr., 2012(4) RCR (Crl.) 543*.

In view of the aforesaid report of the learned Judicial Magistrate Ist Class, Shaheed Bhagat Singh Nagar accompanied by statements of both the parties, the FIR No.0001 dated 25.03.2022 under Sections 406, 420, 120-B IPC and Section 3 of the Punjab Travel Professionals (Regulation) Act, 2014 registered at P.S. NRI, District SBS Nagar and all consequential proceedings arising therefrom are hereby quashed.

Petition stands disposed of.
