The instant petition has been filed under Articles 226/227 of the Constitution of India for the issuance of a writ in the nature of mandamus directing the respondents to release the due payment of Rs. 31,85,185/- qua the works executed by the petitioner alongwith interest @ 12% per annum.

Learned counsel appearing on behalf of the petitioner contends that the petitioner was allotted work of Augmentation of Water Supply Schemes, Village Ubhawal vide allotment letter No. 01 dated 10.05.2021. The petitioner has successfully completed this work on 30.06.2022 well within the stipulated period. The final bill amounting to Rs. 26,99,886/- and security amount of Rs. 4,85,299/- total amounting to Rs. 31,85,185/- has not been released to the petitioner till date.

It is contended that the bill with respect to the aforesaid work has already been sent to the respondent-authorities and various representations including Legal Notice dated 26.04.2023 (Annexure P-3) has been sent by the petitioner to the respondent No.5-the Executive Engineer, Water Supply & Sanitation Division, Sangrur for release of due payment.

Learned counsel appearing on behalf of the petitioner contends that he would be satisfied at this juncture in case the respondent No.5-the Executive Engineer, Water Supply & Sanitation Division, Sangrur is directed to look into the Legal Notice dated 26.04.2023 (Annexure P-3) respectively and to pass a reasoned and speaking order thereupon in a time bound manner.

Notice of motion.

Mr. Saurav Verma, Addl. A.G. Punjab appears and accepts notice on behalf of respondents and he has no objection in the event such prayer of the petitioner as aforesaid is accepted.

Accordingly, the present petition is disposed of with consent and without commenting on the merits of the claim, with a direction to respondent No.5-the Executive Engineer, Water Supply & Sanitation Division, Sangrur to examine the grievance espoused by the petitioner in the Legal Notice dated 26.04.2023 (Annexure P-3) and to pass a reasoned and speaking order thereupon within a period of 03 months of the receipt of certified copy of this order after affording an opportunity of hearing to the respective parties.
