The instant application has been filed under Section 151 of the Code of Civil Procedure, 1908 seeking permission for placing on record a copy of the order dated 24.05.2023 (Annexure A-1) passed by the Naib Tehsildar, Thanesar, District Kurukshetra, Haryana withdrawing the order dated 10.05.2023 (Annexure P-1).

Application is allowed as prayed for and copy of the order dated 24.05.2023 (Annexure A-1) is taken on record.

the captioned writ petition.

Counsel for the applicant-petitioner contends that challenge in the writ petition is to the order dated 10.05.2023 passed by the Naib Tehsildar, Thanesar, District Kurukshetra (Annexure P-1) whereby the Caste Certificate issued in favour of the petitioner had been cancelled. It is averred that the applicant-petitioner had thereafter submitted a representation to the respondent-authorities on 12.05.2023 and that the said representation has been allowed by the Naib Tehsildar, Thanesar, District Kurukshetra vide order dated 24.05.2023.

Consequently, the writ petition has been rendered infructuous.

Notice of the application.

Mr. Vivek Saini, Addl. A.G. Haryana accepts notice on behalf of the respondents and has no objection to the hearing of the main writ petition being pre-poned from 14.09.2023 and to be taken up on any other suitable date.

The instant application is accordingly allowed. Hearing of the main case is pre-poned from 14.09.2023 and the same is taken on Board today itself.

The writ petition raised a challenge to the cancellation to the Caste Certificate vide order dated 10.05.2023 (Annexure P-1) by the Naib Tehsildar, Thanesar.

During the pendency of the present writ petition, the above
