For the reasons mentioned in the application as well as arguments addressed, leave to file this appeal without registration as Advocate on Roll, is granted, subject to just exceptions.

Application is accordingly disposed of.

1. The present petition has been preferred seeking the issuance of a writ of *mandamus* directing respondent No.2 and 3 to protect the life and liberty of the petitioners as they apprehend a threat to their lives from respondent Nos.4 to 7.

2. Learned counsel for the petitioners contends that the petitioners are living in a live-in relationship. He submits that both are majors. The copies of 'Aadhaar' card (Annexures P-1 and P-2) of petitioner Nos.1 and 2 have been placed on record.

4. On the asking of the Court, Mr. Dhruv Dayal, Addl..A.G., Punjab, appears and accepts notice on behalf of the official respondents.

5. Mr. Rajesh Bhaiteja, Advocate has put in appearance on behalf of respondents No.4 and 5, who are the parents of petitioner No.1. He submits that the marriage of petitioner No.1 is fixed with some other boy for 27.06.2023. He makes a prayer that a direction be issued to petitioner No.1 to appear in the Court.

6. The petitioners have approached this Court with the prayer that their life is in danger on account of the fact that they are living in a live-in-relationship. Under the circumstances, I do not deem it appropriate to issue any direction at this moment to the petitioners to appear before the Court, lest any untoward incident may take place. Respondents No.4 and 5 may, if so advised, avail other remedies available in law.

For the time being, without commenting on the validity of the relationship, the present petition is disposed of with a direction to respondent No.2 to consider the representation dated 24.05.2023 (Annexure P-3) and take requisite action, if so warranted, as per the facts and circumstances of the matter in accordance with law.
