1. Vide this common order, this Court intends to dispose off all the aforesaid petitions together, as common question of law is involved in all the petitions.

2. Just to avoid the repetition, facts are being taken from CWP-11529-2020 titled as '*Baljit Singh vs. State of Haryana and Anr.*'.

3. The jurisdiction of this Court has been invoked under Article 226 of the Constitution of India for issuance of a writ in the nature of mandamus directing the respondents to grant the benefit of one increment,

which becomes due on 01.07.2009 alongwith all consequential benefits with a further direction to respondents to revise the pay and pension accordingly and release all the pensionary benefits, arrears alongwith interest @ 18 % per annum.

4. The grievance of the petitioner(s) in all the petitions is that they have not been granted the benefit of one notional increment with pensionary benefits which became due w.e.f., 01.07.2009, in the light of amendment in Rule 10 of Haryana Civil Services Revised Pay Rules, 2008 and Rule 20 of Haryana Civil Services (ACP) Rules, 2008.

5. Learned counsel for the parties concede the factum that the issue raised in the aforesaid petitions is covered by the judgment of the Hon'ble Supreme Court of India in Civil Appeal No. 2471 of 2023 titled as **The Director (Admn. And HR) KPTCL & Others Vs. C.P. Mundingamani and others**, decided on **11.04.2023**, hence, the present petitions be also disposed of in the same terms and conditions.

5. Ordered accordingly.
