On 23.05.2019, fresh notice was issued to respondent No.1 for 28.01.2020, through ordinary process, registered post and dasti as well, on furnishing his correct address etc. Vide the said order, it was made clear to the petitioner that in case of non-compliance of this order in its letter in spirit, this revision would entail dismissal for want of prosecution.

On 28.01.2020 the following order was passed:-

“For non-compliance of the previous order, the instant criminal revision petition is liable to be dismissed.

However, learned counsel for the petitioner regrets for non-compliance of the previous order.

In view of the persistent requests of learned counsel for the

petitioner, last opportunity is granted to the petitioner to serve respondent No.1 strictly in compliance of the order dated May 23, 2019, failing which, this petition shall be dismissed outrightly, without affording further opportunity for compliance of order dated May 23, 2019.

Adjourned to 23.07.2020.”
