Prayer in the application is for preponing the date of hearing of the present writ petition from 21.09.2023 to any early date.

Notice in the application to the non-applicant/respondent.

Mr. Pankaj Midha, Addl. A.G., Haryana, who is present in Court, accepts notice for the non-applicant/respondent.

For the reasons stated in the application, which is duly supported by an affidavit, the same is allowed and on joint prayer of both the parties, the main case is taken up for hearing today itself.

CWP No.13163 of 2023

The present petition has been filed with the prayer that the respondent-Commission be directed to recommend the name of the petitioner for appointment on Group D post in pursuance to the advertisement No.4/2018 as similarly situated persons have already been granted appointment.

Learned counsel for the petitioner argues that the petitioner was found suitable for appointment to the Group D post under quota of Eligible Sports

Persons (ESP) but he was kept in waiting list and though appointments to the said post have been made from the waiting list but claim of the petitioner has not been considered, hence, respondent-Commission is under obligation to consider the claim of the petitioner for grant of appointment.

Learned counsel for the petitioner further argues that the grievance raised by the petitioner in the present petition has already been raised in the representation dated 14.12.2022, copy of which has been appended as Annexure P-5, hence, the petitioner would be satisfied at this stage, in case, respondent-Commission is time bound to decide the said representation by passing an appropriate speaking order.

Notice of motion.

Mr. Pankaj Midha, Addl. A.G., Haryana, who is present in Court, accepts notice for the respondent and submits that in case representation dated 14.12.2022 (Annexure P-5) is still pending consideration before the respondent-Commission, the same will be decided by passing an appropriate speaking order within a period of 8 weeks from the date of receipt of copy of this order and in case, after the said decision, any benefit accrues to the petitioner, the same will be extended to him within a further period of four weeks.

Learned counsel for the petitioner submits that keeping in view the statement made by the learned State counsel, the present petition may kindly be disposed of having been not pressed any further.

Ordered accordingly.
