VIVEK PURI, J.(ORAL)

1. The petitioners are seeking to quash the FIR No.99 dated 28.08.2021 under Sections 323 and 341 IPC registered at Police Station Sultanwind, District Police Commissionerate Amritsar and all the consequential proceedings arising therefrom on the basis of compromise.
2. On 05.06.2023, the parties were directed to get their statements recorded before the learned trial Court/Area Magistrate.
3. In compliance of the order dated 05.06.2023, the statements of the parties have been recorded and the learned Judicial Magistrate 1st Class, Amritsar has sent the report and the relevant portion whereof is reproduced here-in-below:-

“It is further submitted that while recording the statements of both the parties, it has been ensured that in the present FIR, the complainant/respondent Manpreet Singh and accused persons/petitioners Jagbir Singh, Amardeep Singh @ Sonu Sohal and Randeep Singh @ Hardeep Singh have appeared before the

court. Further, as per their statements, the compromise has been arrived at between them. The compromise is genuine, voluntary and without any pressure, being outcome of their free will. As per statements of the parties and investigating officer, there is no other accused person in the present F.I.R except the petitioners. No accused has been declared proclaimed offender at any stage of trial. ”

4. The allegations against the petitioners are to the effect that they had inflicted injuries on the person of respondent No.2. The injuries attributed to the petitioners fall under Section 323 IPC. It is a case of version and cross-version. The dispute has been amicably settled between the parties in terms of the compromise, Annexure P-2. An amicable settlement will help in maintaining cordial relations between the parties in future. A separate petition bearing CRM-M-29704-2023 for quashing of GD number has also been quashed.

5. Learned counsel for respondent No.2 has not disputed the aforesaid factual aspect(s) and further stated that he has no objection if the FIR is quashed.

6. After hearing learned counsel for the parties and going through the record of the case, this Court is of the considered opinion that it is a fit case for exercising the inherent jurisdiction of this Court under Section 482 Cr.P.C., so as to secure the ends of justice because the parties have arrived at a settlement, out of the Court, by way of compromise. The compromise is without any pressure and a genuine one. In such a situation, continuation of the prosecution would result in sheer abuse of process of law.

7. The controversy in the instant case does not indicate that the same involves heinous or serious offences and furthermore, the private dispute has been sought to be amicably settled. Consequently, a deserving case is made out where

the court should exercise the power to secure the ends of justice.

8. For the aforesaid view, this Court finds support from *Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR (Criminal) 1052*, upheld by Hon'ble Apex Court in *Gian Singh Vs. State of Punjab and others (2012) 10 SCC 303*.

9. Considering the peculiar facts and circumstances of the case noted above, coupled with the reasons aforementioned and to secure the ends of justice, FIR No.99 dated 28.08.2021 under Sections 323 and 341 IPC registered at Police Station Sultanwind, District Police Commissionerate Amritsar and all the consequential proceedings arising therefrom on the basis of compromise are ordered to be quashed, however, qua the petitioners only.

10. Resultantly, with the above-said observations made, the instant petition stands allowed.
