Status report by way of affidavit dated 18.06.2023 of Jitender Kumar, HPS, Deputy Superintendent of Police, Nuh has been filed on behalf of respondents No.1, 3 and 5 in the Court today. The same is taken on record and the said report reads as under:-

1. That the present status report by way of affidavit is being filed in pursuance of the order dated 14.06.2023 passed by this Hon'ble High Court in the above titled case. The said order is reproduced as under:-

Notice of motion.

On the asking of the Court, Mr. Pawan Kumar Longia, Deputy Advocate General, Haryana, accepts notice on behalf of respondents No.1 to 5 and seeks time to have instructions.

2. That the petitioner has approached this Hon'ble Court, by way of filing the present petition, for seeking issuance of writ in the nature of habeas corpus for appointment of Warrant Officer of this Hon'ble official respondents to trace out and produce before this Hon'ble Court the detenue namely Sanovar who the petitioner has alleged to be in illegal custody of respondent no. 6 to 8.

3. That in this context, it is submitted that FIR No. 97 dated 13.05.2023 u/s 346 IPC was registered at P.S. Pinagwan, Distt. Nuh on the complaint filed by Javed Hussain. The investigation of the said FIR is going on.

4. That in the meantime, the petitioner got registered FIR No. 205 dated 13.06.2023 u/s 365 IPC at P.S. Civil Lines, Kaithal against Tarif Hussain, Aarif Javed, Haider, Ayub, Yakub, Umardin, Musleem on the allegations that the alleged detenue Sanovar was residing in a live in relationship with the petitioner and they were provided protection by this Hon'ble Court. The alleged detenue Sanovar was residing in Room No. 203, Star Inn Hotel, Near Padma City Mall. On 13.06.2023 at around 9:32, a telephonic message was received from Hotel owner from his mobile no. 7082651515 that 15-20 persons are forcibly taking away the girl residing with him. He named the above named persons after seeing the video footage of the said incident. The Kaithal Police conducted the raid in Pinagwan, Distt. Nuh but the alleged detenue Sanovar and her family members could not be initially traced out.

5. That now, the alleged detenue Sanovar has been recovered on 17.06.2023 and her statement u/s 164 Cr.PC has been recorded before the Ld. Duty JMIC, Ferozpur Jhirka. In which she stated that she is residing with Wasim in a live in relationship without any force OATH C a on her own will. Wasim has not taken any forcible step against She still wants to go with Wasim and live with him. She further stated that she does not want any action in the case registered against Wasim under Section 346 IPC.

6. That thereafter, the alleged detenue Sanovar has been handed over to the petitioner Wasim Ahmed on 17.06.2023 vide handing over memo dated 17.06.2023.

7. That as of now, the alleged detenue is with the petitioner Wasim Ahmed and as such his prayer has been accomplished and

the present petition becomes infructuous and deserves to be dismissed accordingly.

In view of the above, nothing survives in the present petition and accordingly the same is dismissed as having been rendered infructuous.
