1. This is a Civil Writ Petition filed under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of mandamus directing respondent No.3 to release the stage carriage permit granted in response to the grant letter dated 11.04.2023 for the grant of stage carriage permit on the route Budhlada to Jhunir (Annexure P-1) issued by respondent No.3 after completion of required legal formalities under the provisions of Motor Vehicles Act, 1988. Further prayer has been made for directing respondent No.3 to provide access code/password for deposit of online permit fee which has not been provided to the petitioner.

2. Learned counsel for the petitioner has submitted that in the present case, since, the access code/password for depositing of online permit fee has not been granted to the petitioner, thus, he is unable to deposit the fee,

although, he is fully eligible for the same. It is further submitted that for the grievances raised by the petitioner in the present writ petition, the petitioner had given a representation dated 05.07.2023 (Annexure P-2) to respondent No.3 and he would be satisfied at this stage, in case, the said respondent No.3 is directed to consider the said representation dated 05.07.2023 (Annexure P-2) in a time bound manner and in case, the pleas raised by the petitioner are found to be meritorious then to grant necessary relief as expeditiously as possible.

3. Learned State Counsel has submitted that respondent No.3 would consider the representation dated 05.07.2023 (Annexure P-2) in accordance with law, as expeditiously as possible.

4. Keeping in view the abovesaid facts and circumstances, the present Civil Writ Petition is disposed of with direction to respondent No.3 to consider the representation dated 05.07.2023 (Annexure P-2) within a period of two weeks from the date of receipt of certified copy of the present order and in case, the pleas raised by the petitioner are found to be meritorious then respondent No.3 would grant appropriate relief, in accordance with law as expeditiously as possible and in case, respondent No.3 is of the opinion that the pleas raised by the petitioner are not found to be meritorious then a speaking order rejecting the same be passed within a period of three weeks from today.

5. This Court has not opined on the merits of the case and respondent No.3 would consider the case of the petitioner independently and in accordance with law.
