The instant petition has been instituted under Articles 226/227 of the Constitution of India, 1950 seeking issuance of a writ in the nature of Mandamus directing the respondents to release the due payment of Rs.3,51,400/- qua the works executed by the petitioner, alongwith interest @ 12% per annum.

Learned counsel for the petitioner contends that the petitioner had executed various works assigned to him from time to time and there has never been any complaint against the works executed by the petitioner. On 17.08.2021, the work of Digital Survey of various villages with Total Station and EPA NET of Block Guruharsahai in District Ferozepur was allotted to the petitioner vide EE Sanction No. 2619 dated 17.08.2021 and the same was duly completed but the due payment has not been released till date. The details of the works and the amount payable to the petitioner have been duly

given in paragraph No.3 of the petition. It is further submitted that there is no dispute with regard to successful completion of the works and as well as the amount claimed. The petitioner approached the respondents for a number of times, but nothing fruitful could be fetched. Thereafter, the petitioner submitted numerous representations but of no avail. Lastly, the petitioner served a legal notice dated 14.06.2023 (Annexure P-3) upon respondent No.5 but the respondents neither responded to the same nor did they make the payment of outstanding amount of the petitioner.

Notice of motion.

Mr. Saurav Verma, Addl. A.G., Punjab accepts notice on behalf of respondents and prays for some time to file response, if any.

Learned counsel for the petitioner, however, submits that at this juncture, he would be satisfied if respondent No.5- The Executive Engineer, Water Supply and Sanitation Division No.2, Ferozepur is directed to consider and decide the legal notice dated 14.06.2023 (Annexure P-3) in a time bound manner.

Learned counsel for the respondents does not oppose the prayer made by learned counsel for the petitioner.

Accordingly, in view of the above, with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.5 to consider and decide the legal notice dated 14.06.2023 (Annexure P-3) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that upon considering the said legal notice, if any amount is found due and payable to the petitioner, the same shall be disbursed in his favour within a further period of three months.

Petition stands disposed of accordingly.
