This order will dispose of nine Civil Writ Petitions bearing Nos.22992, 23595, 23610, 23612, 23615, 23870, 23871, 23872 and 26487 of 2016 as common question of facts and law are being involved.

Counsel representing the respondents submit that challenge in these petitions is to the memorandum/charge-sheet/inquiry report/second show-cause notice etc. He submits that all the inquiry proceedings have been concluded and final orders have been passed. Counsel submits that these writ petitions have become infructuous.
