HARNARESH SINGH GILL, J. (ORAL)

1. Through this fourth petition, the petitioner seeks regular bail in case bearing FIR No.128 dated 26.06.2020, registered under Sections 15 and 25 of the NDPS Act, at Police Station Sangat Bathinda, District Bathinda.
2. Status report by way of affidavit dated 08.08.2023 of the Deputy Superintendent of Police (Rural), Bathinda, submitted by the learned State counsel in the Court, is taken on record.
3. Learned counsel for the petitioner submits that the petitioner has falsely been implicated in the present case; that the petitioner has been indicted in the present case, being the owner of the truck-tralla in question; that that though the recovery effected from the truck-tralla falls under the commercial quantity, yet the fact remains that the same was handed over to the driver and conductor and the alleged recovery 90 kg. of poppy-husk was effected from an isolated place; that out of 20 prosecution witnesses, only 01 has been examined so far and that the petitioner has been in custody since 08.07.2020. It is further submitted that there is no other registered or pending

case against the petitioner, at least of a similar nature.

4. In support of his case, learned counsel for the petitioner relies upon the orders dated 25.01.2023, passed by the Hon'ble Supreme Court in Special Leave to Appeal (Crl.) No(s).6690/2022, titled as 'Dheeraj Kumar Shukla Vs. State of Uttar Pradesh'.

5. Per contra, while opposing the prayer for grant of regular bail to the petitioner, learned State counsel does not dispute the custody period of the petitioner and the fact that the petitioner is not involved in any other case under the NDPS Act. He, however, submits that the recovery effected from the petitioner falls under the commercial quantity and that Section 37 of the NDPS Act bars the grant of bail to the accused in case of commercial quantity. He further submits that the material witnesses are yet to be examined.

6. I have heard the learned counsel for the parties.

7. Though the recovered contraband in the present case, falls under the commercial quantity, yet the fact remains that the petitioner has been in custody since 08.07.2020 and that remaining 20 prosecution witnesses are yet to be examined. In such circumstances, trial of the case would take a long time to conclude. There is no other case under the NDPS Act registered or pending against the petitioner. Therefore, no useful purpose would be served by keeping the petitioner behind the bars.

8. The Hon'ble Apex Court in 'Dheeraj Kumar Shukla's case (supra) has held as under:

'3. It appears that some of the occupants of the `Honda City' Car including Praveen Maurya @ Puneet Maurya have since been released on regular bail. It is true that the quantity recovered from the petitioner is commercial in nature and the provisions of Section 37 of the Act may ordinarily be attracted. However, in the absence of criminal antecedents and the fact that the petitioner is in custody for the last two and a half years, we are satisfied that the conditions of Section 37 of the Act can be dispensed with at this stage, more so when the trial is yet to commence though the charges have been framed.

4. For the reasons stated above but without expressing any views on the merits of the case, the petitioner is directed to be released on bail subject to his furnishing bail bonds to the satisfaction of the Trial Court.

5. It is made clear that in addition to the conditions that may be imposed by the Trial Court, the petitioner shall be required to appear before the Trial Court on every date of hearing. In case the petitioner is found to be involved in future in any other similar case, the respondent – State shall be at liberty to seek cancellation of bail granted to him by this Court.

6. The Special Leave Petition stands disposed in the above terms.....'.

9. In view of the above, this Court finds that no useful purpose would be served by keeping the petitioner behind the bars. Resultantly, without commenting anything on the merits, lest it should prejudice the case of either side, the present petition is allowed and the petitioner is ordered to be released on bail on his furnishing bail and surety bonds to the satisfaction of the learned trial Court/Duty Magistrate.
