This is an application under Section 482 Cr.P.C for placing on record the copy of Mutation No. 3598 dated 12.06.2019 (Annexure P-7) and copy of Aks-Shijra dated 19.01.2023 (Annexure P-8).

For the reasons assigned in the application, the same is allowed and Annexures P-7 and P-8 are taken on record.

Through the instant petition under Section 482 Cr.P.C., praying for quashing of case in FIR No.298 dated 14.06.2021, registered under Sections 3, 7(i) and 7(ii) of Haryana Development and Regulation of Urban Areas Act, 1975, at Police Station Azad Nagar, District Hisar.

Short report dated 24.01.2023 by way of affidavit of Superintendent of Police, Hisar on behalf of respondent Nos. 1 and 2 filed in the Registry is taken on record.

Learned counsel for the petitioner submits that the Maharaja Aggarsain Cooperative House Building Society Limited has been falsely involved in the present case.

Learned State counsel submitted that Coordinate Bench of this Court vide order dated 11.01.2023 directed the Superintendent of Police, Hisar to file an affidavit regarding the time frame investigation. As per the affidavit dated 24.01.2023, the Superintendent of Police, Hisar seeks 90 days more to complete the investigation after taking record from the petitioner society.

It is further submitted by the State counsel that as per the instructions from ASI Krishan Kumar till date nothing has been found against the petitioner society and the investigation is still going on. Whenever, anything is found against the petitioner after taking more documents from the petitioner-society they will issue an advanced notice to the petitioner.

I have heard learned counsel for the parties.

As per the affidavit dated 24.01.2023 Superintendent of Police, Hisar sought 90 days more time to complete the investigation after taking more documents from the petitioner-society. It has also been come on record that the till date nothing has been found against the petitioner. Investigation is still going on. If anything against the petitioner is found investigation agency is free to call petitioner by issuing an advance notice.

The present petition stands disposed of.
