1. This is an application filed under Section 151 of CPC for preponement of the date of hearing in the main case which is now stated to be listed for 02.11.2023 to today.

2. Learned counsel for the applicants-petitioners has submitted that the applicants-petitioners wish to withdraw the main writ petition and thus, pray for allowing of the present application.

3. On the other hand, learned State Counsel who is appearing on behalf of respondent Nos.1 to 4 as well as learned counsel for respondent No.5, have submitted that they have no objection in case the present application is allowed and the date of hearing in the main case is preponed from 02.11.2023 to today itself for final disposal.

side, the present application is allowed and the date of hearing in the main case is preponed from 02.11.2023 to today and the same is taken on Board today itself for final disposal.

CWP-25575-2016 (O&M) and CM-8109-CWP-2023

1. This is a Civil Writ Petition filed under Articles 226/227 of the Constitution of India for issuance of a writ, order or direction especially in the nature of certiorari for setting aside the order dated 24.10.2016 (Annexure P-11 Colly) passed by the Financial Commissioner, Punjab-respondent No.1, whereby two set of revision petitions against the *sanad takseem* were dismissed.

2. Learned counsel for the petitioners has submitted that since, the matter has been compromised between the parties, thus, the petitioners wish to withdraw the main writ petition and with respect to the same, they have filed an application bearing No.CM-8109-CWP-2023 for withdrawal of main writ petition which is duly supported by an affidavit of petitioner No.2. It is thus, prayed that the same may kindly be allowed.

3. Keeping in view the abovesaid facts and circumstances as well as prayer made in the application bearing No.CM-8109-CWP-2023, the same is allowed.

4. In view of the above, the main Civil Writ Petition bearing No.CWP-25575-2016 is dismissed as withdrawn.

5. All the pending miscellaneous applications, if any, shall stand disposed of in view of the abovesaid order.
