SANDEEP MOUDGIL, J (ORAL)

1. The jurisdiction of this Court has been invoked under Section 439 Cr.P.C., seeking regular bail to the petitioner in FIR No.143, dated 13.06.2022, under Section 22(a) of Narcotic Drugs and Psychotropic Substances Act, 1985, registered at Police Station City Malout, District Sri Muktsar Sahib.

2. Learned counsel for the petitioner submits that the petitioner has been falsely implicated in the present case, as the prosecution has failed to explain as to which of the accused was holding the transparent plastic polythene. It is contended on behalf of the petitioner that out of total 13 prosecution witnesses none has been examined after framing of charges on 26.10.2022.

3. Learned State counsel has produced the custody certificate of the petitioner, which is taken on record, to demonstrate that she has suffered incarceration for a period of 01 year 4 months and 19 days. He opposes the prayer made in the present petition stating that there is recovery of 80 intoxicating tablets, which falls under the commercial quantity. Though, he does not controvert the fact that after framing of charges on 26.10.2022 out of total 13 prosecution witnesses none has been examined till date.

4. From perusal of custody certificate, it is evident that the petitioner is having clean antecedents.
5. Considering the fact that the petitioner is 56 years old lady and has suffered incarceration of 1 year, 4 months and 19 days added with the fact that the trial is moving at the snail's pace as out of total 13 prosecution witnesses none has been examined after framing of charges on 26.10.2022 so far, which curtails the right of the petitioner for speedy trial and expeditious disposal, as enshrined under Article 21 of the Constitution of India.
6. In view of the aforesaid discussions made hereinabove, the petitioner is directed to be released on regular bail subject to her furnishing bail and surety bonds to the satisfaction of the trial Court/Duty Magistrate, concerned.
7. In the afore-said terms, the present petition is hereby allowed.
8. However, it is made clear that anything stated hereinabove shall not be construed as an expression of opinion on the merits of the case.
