AMAN CHAUDHARY. J.

The present petition has been filed under Section 439 Cr.P.C. for the grant of regular bail to the petitioner in respect of FIR No.464 dated 19/20.09.2021, under Sections 323, 506, 34 of the IPC (Sections 302, 379-B of the IPC added later on) registered at Police Station Meham, Rohtak, District Rohtak.

Learned counsel contends that the petitioner is in custody for the last 1 year and 4 months having been arrested on 04.10.2021. Petitioner was not named in the FIR, however, his name surfaced based on disclosure statement of co-accused Vikas. In all there are 20 witnesses out of which, only 03 including the complainant have been examined and he has not supported the prosecution version. The petitioner is not involved in any other case.

Learned State counsel opposes the bail on the ground that the main accused had disclosed the name of the petitioner and he was present on the spot at the time of occurrence and caused injuries. He is however unable to controvert the submissions made by learned counsel for the petitioner regarding custody, stage of the trial and that he is not involved in any other case.

Heard.

In view of the facts and circumstances of the case, in particular that the petitioner is in custody for the last 1 year and 4 months; out of 20 prosecution witnesses, only 03 including the complainant have been examined, who has not supported the case of the prosecution; the trial is likely to take a considerable time, his further detention behind bars would not serve any useful purpose, thus the present petition for grant of regular bail deserves to be allowed.

As a result, the present petition is allowed. The petitioner is ordered to be released on regular bail, subject to his furnishing bail/surety bonds to the satisfaction of trial Court/Duty Magistrate concerned and subject to him not being required in any other case. The petitioner shall abide by the following conditions:-

1. The petitioner will not tamper with the evidence during the trial.
2. The petitioner will not pressurize/ intimidate the prosecution witnesses.
3. The petitioner will appear before the trial Court on each and every date fixed, unless is exempted by a specific order of Court.
4. The petitioner shall not commit an offence similar to the offence of which, he is an accused, or for commission of which he is suspected of.
5. The petitioner shall not directly or indirectly coerce, induce, threaten or promise to any person acquainted with the facts of the case so as to dissuade him/ her from disclosing such facts to the Court or to any police officer or tamper with the evidence in any manner.
6. The petitioner shall not in any manner misuse his liberty.
7. The petitioner shall furnish his address and mobile number to the Trial Court forthwith and shall not change the same till the conclusion of the trial and in case for any reason, the petitioner seeks to change any of the aforesaid, the same shall be done only with prior intimation to the learned Trial Court, stating the reason for the same.
8. The petitioner shall deposit his passport, if any, with the Trial Court forthwith and in case, he does not have the passport, he shall furnish a specific affidavit in this regard.

It is made abundantly clear that in case there is any breach of the aforesaid conditions, the State shall be at liberty to seek cancellation of bail as

granted to the petitioner by this order.

In view of the above, this Court makes it clarified that the observations made herein above are limited for the purpose of present proceedings and would not be construed as any opinion on the merits of the case and the trial would proceed independently of the aforesaid observations.
