behalf of legal heirs of respondent No.1 in court today, with No Objection
from the earlier counsel, the same is taken on record.

Prayer in this application is to bring on record the legal heirs of
deceased respondents No.1 and 2.

This application has been moved by the legal heir of respondent
No.1-Dr.Harinder Singh Rattan Pal on the basis of Will, affidavits and
authority letters given by the other legal heirs of the deceased-respondents.

It is submitted that respondent No.1-Jagir Singh died on
18.12.2018 leaving behind the applicant-Dr.Harinder Singh Rattanpal as his
only legal heir by executing a Will dated 22.11.2018. The other legal heirs of

the deceased i.e. his wife and daughter have given No Objection in favour of the applicant before the Executing Magistrate at Ludhiana. During the pendency of present appeal, respondent No.2-Dalip Singh also died, leaving behind his legal heirs as mentioned in para No.7 of the application. They all have given authority letters that the applicant-Dr.Harinder Singh Rattanpal is the only competent and authorized person to represent the deceased respondent.

In view of the averments made in the application, the same is allowed. The legal representative as mentioned in the application are ordered to be impleaded through the respective deceased respondents subject to just exceptions.

The amended memo of parties filed is taken on record.

Prayer in this application is for withdrawal of the regular second appeal on the basis of mutual settlement arrived at between the parties on 10.08.2023 (Annexure A-1).

For the reasons mentioned in the application, the same is allowed. The appeal which stood admitted vide order dated 20.08.2009 is ordered to be taken on board today itself.
