This third petition has been filed by the petitioner under Section 439 of the Code of Criminal Procedure, 1973 seeking regular bail in case FIR No.104 dated 03.09.2022 (Annexure P-1) under Sections 15, 29, 61, 85 of Narcotic Drugs and Psychotropic Substances Act, 1985, registered at Police Station Chhabewal, District Hoshiarpur.

In Para 10 of the petition, it has been stated as under:-

**“xxx xxx xxx xxx**

*That except the present case under NDPS Act one other case is registered against the petitioner bearing FIR No.160 dated 21.08.2022.”*

**xxx xxx xxx xxx”**

Learned State counsel has filed custody certificate giving details of five cases which have been registered against the petitioner. The particulars of the same are as under:-

- “(I)     *FIR No.140 dated 28.07.2022, under Sections 160, 336, 307, 148, 149 IPC and Sections 25, 27, 54, 59 of Arms Act, registered at Police Station Mahilpur.*
- (II)     *FIR No.160 dated 21.08.2022, under Sections 307, 336, 506, 34 IPC and Sections 25, 54, 59 of Arms Act, registered at Police Station Mahilpur.*
- (III)    *FIR No.32 dated 24.07.2022, under Sections 392, 201, 34 IPC, registered at Police Station Pojewal.*
- (IV)    *FIR No.315 dated 09.11.2022, under Section 52-A of Prisons Act, registered at Police Station City Hoshiarpur.*
- (V)     *FIR No.44 dated 23.02.2023, under Section 52-A of Prisons Act, registered at Police Station City Hoshiarpur.”*

Faced with this situation, learned counsel for the petitioner wishes to withdraw the present petition at this stage.

Dismissed as withdrawn at this stage.
