AMAN CHAUDHARY. J.

The present petition has been filed under Section 439 Cr.P.C. for the grant of regular bail to the petitioner in respect of FIR No. 254 dated 08.08.2020 under Sections 307, 452, 34,120-B IPC and Sections 25 (6, 7, 8), 54 and 59 of the Arms Act registered at Police Station Maqboolpura, District Police Commissionerate Amritsar.

Learned counsel for the petitioner contends that the petitioner has been in custody since 13.09.2020. The allegations against the petitioner are of having injured the knee of the petitioner by a gun shot which was declared as grievous and not dangerous to life. Charges were framed on 20.08.2022, however, none out of 25 prosecution witnesses have been examined and the trial is likely to take sufficiently long time.

Learned State counsel opposes the bail on the ground that the injury

was caused by gun shot and he is involved in two other cases of similar nature. However, he is unable to controvert the other submissions made by learned counsel for the petitioner in particular with regard to custody, stage of the trial and that the injury caused has been declared as grievous being on the on non-vital part of the body.

Heard.

In view of the facts and circumstances of the case, in particular that the petitioner has been in custody since 13.09.2020; charges have been framed and there are a total of 25 prosecution witnesses out of whom, none have been examined; the trial is likely to take a considerable time, his further detention behind bars would not serve any useful purpose, thus the present petition for grant of regular bail deserves to be allowed.

As a result, the present petition is allowed. The petitioner is ordered to be released on regular bail, subject to his furnishing bail/surety bonds to the satisfaction of trial Court/Duty Magistrate concerned and subject to him not being required in any other case. The petitioner shall abide by the following conditions:-

1. The petitioner will not tamper with the evidence during the trial.
2. The petitioner will not pressurize/ intimidate the prosecution witnesses.
3. The petitioner will appear before the trial Court on each and every date fixed, unless is exempted by a specific order of Court.
4. The petitioner shall not commit an offence similar to the offence of which, he is an accused, or for commission of which he is suspected of.
5. The petitioner shall not directly or indirectly coerce, induce, threaten or promise to any person acquainted with the facts of the case so as to dissuade him/ her from disclosing such facts to the

Court or to any police officer or tamper with the evidence in any manner.

6. The petitioner shall not in any manner misuse his liberty.

7. The petitioner shall furnish his address and mobile number to the Trial Court forthwith and shall not change the same till the conclusion of the trial and in case for any reason, the petitioner seeks to change any of the aforesaid, the same shall be done only with prior intimation to the learned Trial Court, stating the reason for the same.

8. The petitioner shall deposit his passport, if any, with the Trial Court forthwith and in case, he does not have the passport, he shall furnish a specific affidavit in this regard.

It is made clear that in case of any infraction of any of the aforesaid conditions, the State shall be at liberty to seek cancellation of bail as granted to the petitioner by this order.

In view of the above, this Court makes it clarified that the observations made herein above are limited for the purpose of present proceedings and would not be construed as any opinion on the merits of the case and the trial would proceed independently of the aforesaid observations.
