As the main petition is listed for today, the present application seeking preponement of the date of hearing of the main petition has become infructuous.

CWP-20108-2022 and other connected cases

By this common order, five writ petitions, the details of which have been given in the heading, are being decided as all these petitions involve the same question of law on similar facts.

In the present petitions, the grievance which is being raised by the petitioners is that either they were not given the appointment as Clerks despite being in the merit list keeping in view the interim order passed or their services were terminated to be appointed again afresh on the same post and the claim of the petitioners is that they should be considered appointed from the date when the persons junior to them in the merit have been appointed with all consequential benefits.

Learned counsel for the respondents submits that the grievance raised in the present petitions has already been redressed and the benefit of the appointment from the date the persons junior to the petitioners in the merit list were appointed along with consequential benefits have already been granted to the petitioners.

Learned counsel for the respondents further submits that in case any of the selected candidate could not join keeping in view the interim order passed, appropriate action will be taken to grant the petitioners the entitled benefit as expeditiously as possible preferably within a period of eight weeks from today as all the petitions have already been decided. Learned counsel further submits that instructions have already been issued qua the same by the competent authority.

Learned counsel for the petitioners submits that keeping in view the said statement of learned counsel for the respondents, the present petitions have been rendered infructuous and the same may kindly be disposed of as such.

Ordered accordingly.

Learned counsel for the petitioners in CWP No. 25685 of 2022 submits that one of the grievance with regard to the allocation of the department still subsists for which, the petitioners be given liberty to approach the respondents and respondents be directed to decide the said claim in a time bound manner.

Learned counsel for the respondents submits that any representation raising the said claim if received from the petitioners concerned, the same will be dealt with in accordance with law and an appropriate order will be passed within a period of eight weeks of the receipt of any such representation.
