The present petition has been filed praying for quashing of impugned order dated 04.08.2023 passed by respondent no.2 as well as Clause PG-6, 10(III)(a) of the Prospectus for Admission to MD/MS Courses (Session 2023) issued by respondent no.3 College.

2. In the present case, petitioner no.1 has surrendered two seats i.e. one in Anesthesia and another in General Surgery and has opted not to take any seat. Petitioner no.2 has taken seat of Anesthesia at GMCH, Sector 32, Chandigarh., petitioner no.3 has taken seat of Psychiatric at GMCH, Sector 32, Chandigarh., petitioner no.4 has taken seat of Radiodiagnostic at

GMCH, Sector 32, Chandigarh., petitioner no.5 has taken seat of DNB, Plastic Surgery in Sri Ganga Ram Hospital, New Delhi, petitioner no.6 has taken seat of Ophthalmology, Maulana Azad Hospital Delhi and petitioner no.7 has taken seat of Orthopaedics at GMCH, Sector 32, Chandigarh. All the petitioners have got their respective seats as per the prospectus and they have got admission in August, 2023.

3. Learned counsel appearing for U.T. Chandigarh has informed that admissions in GMCH, U.T., Chandigarh have been made as per the criteria approved by the Administrator, Chandigarh and the prospectus (Annexure P-9).

4. Since all the petitioners have got their respective seats, no further directions are required to be passed in this writ petition, at this stage and the same is accordingly disposed of.

4. All the pending application(s), if any, shall also stand disposed of.
