Present writ petition has been filed for issuance of a writ in the nature of certiorari to quash/set aside all the impugned actions of the respondents dated 25.09.2015 (Annexure P-6), Jamabandi for the year 2017-18 (Annexure P-7) and Jamabandi for the year 2019-20 (Annexure P-8) which have an effect of setting aside/cancellation of the conveyance deeds dated 09.05.2008 and 18.01.2011 (Annexures P-1 and P-2). Further prayer for setting aside the consequential mutation No.439 regarding khasra No.26//5(10-4), 6(2-15) kitte 2 area 12-19 situated at village Ibrahimpur and mutation No.703/1 regarding khasra No.38//12(1-10) situated at village Mirzapur, vide which the land allotted to the petitioner, was illegally and wrongly mutated in the name of Government as is shown from the 12th column of the Jamabandi for the year 2012-2013 & 2014-2015 (P-3) and (P-4) without providing any opportunity of hearing has also been made.

It has been contended by learned counsel for the petitioner that the respondents issued letter dated 25.09.2015. In pursuance to the same, the similarly situated persons approached this Court by way of filing **CWP No.25855 of 2015**, which was decided on 07.12.2016. He submits that the petitioner was not the party to the same, however this Court had given direction to issue notice to the petitioner and hear him in accordance with law. He submits that for the redressal of his grievance, the petitioner filed a representation dated 02.05.2023 (Annexure P-10). However, no action has been taken by the respondents in the same.

Notice of motion.

On asking of the Court, Ms. Akshita Chauhan, DAG, Punjab appears and accepts notice on behalf of the respondents-State.

In view of the above, the present petition stands disposed of with a direction to respondent No.2-the Deputy Commissioner, Shaheed Bhagat Singh nagar, Nawanshahar to look into the representation dated 02.05.2023 (Annexure P-10) and decide the same within a period of four weeks from today in accordance with law.
