At the time of hearing, petitioner in person wishes to withdraw the main petition, which is stated to be pending for 14.09.2023.

On oral request of petitioner, main petition is preponed and taken on board today itself.

MAIN CASE

Present writ petition has been filed under Article 226 of the Constitution, *inter alia*, for quashing the impugned orders dated 19.01.2022 (P-19) & 22.02.2019 (P-6).

At the outset, petitioner wishes to withdraw the present petition, unconditionally.
