1. The petitioners pray for the issuance of a writ in the nature of certiorari to quash the orders dated 31.12.2014 and 12.06.2015, whereby respondent no.5 to 12 have been selected and appointed as Assistant Professors pursuant to a meeting of the Departmental Promotion Committee.

2. In the written statement filed by respondent no.5 to 9, it has been submitted that there is no promotion from the post of Senior Lecturer to Assistant Professor as it is the case of re-designation of the post of senior lecturer. The official respondents have highlighted that all the petitioners are junior to the private respondents. A tabulated compilation of information of the petitioners and the respondents has been reproduced which is extracted as under:-
