The learned counsels representing the parties are ad-idem that these writ petitions can conveniently be disposed of in terms of the order passed in **Harbhajan Singh and others vs. State of Punjab and another** (C.W.P.No.28434 of 2019, decided on 15.02.2023) . However, they submit that the respondents while preparing the fresh seniority list should take note of the points mentioned in the interim order dated 27.11.2018, which read as under:-

- I. *The sanctioned cadre strength of “Lecturer (English)” as on 01.01.2017;*
- II. *The number of posts available/vacant in the seventy-five per cent (75%) promotional quota as on 01.01.2017;*
- III. *The details of number of posts which are either filled up in excess or available in the fourteen per cent (14%) reserved quota of Scheduled Caste Category (in the promotional quota) as on 01.01.2017;*
- V. *The first roster point which would be available in the existing operating roster for being filled up in the promotional quota as on 01.01.2017;*
- VI. *Whether the roster points have been followed while issuing promotion orders dated 27.02.2017 (Annexure P-9 & P-9). ”*

The learned counsel representing the State submits that the Competent Authority while determining the *inter-se* seniority shall take into consideration the law on the subject and an appropriate speaking order dealing with all objections shall be passed.

Disposed of accordingly.

All the pending miscellaneous applications, if any, are also
disposed of.
