Instant petition has been filed under Section 482 Cr.PC for quashing of FIR No.36 dated 13.05.2022, under Sections 452, 325, 324, 323, 148 and 149 of IPC, registered at Police Station Kalanaur, all the subsequent proceedings arising out of the same, on the basis of compromise arrived at, between the parties.

Learned counsel for the petitioners submits that the present FIR is an outcome of some dispute between the parties. Subsequent to the registration of FIR, a compromise was arrived at between the parties and as a result of which, the petitioners moved this Court qua quashing of FIR in question.

Vide order dated 11.11.2022 of this Court, the parties were directed to appear before the Illaqa Magistrate/trial Court, Gurdaspur on 30.11.2022 to get their respective statements recorded regarding the compromise arrived at, between them.

Report dated 21.12.2022 has since been received from the Judicial Magistrate Ist Class, Gurdaspur in pursuance to the direction of this Court. As per the report, compromise has indeed been effected between the parties and the same is genuine, voluntary, out of their own free will and without any pressure. The trial Court has annexed the statement of the parties alongwith its report.

Learned State counsel also submits that there are no other accused other than the petitioners and respondent No.2 is the only aggrieved person in the FIR in question.

In view of the report of the Civil Judge (Junior Division), Bahadurgarh and the principles laid down by the Apex Court in '*Gian Singh Vs. State of Punjab and others, (2012) 10 SCC 303*', and also by the Full Bench of this Court in '*Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR (Criminal) 1052*', the instant petition is allowed. The aforesaid FIR along with all subsequent proceedings arising out of them, are quashed.

Needless to say the parties shall remain bound by the terms of compromise and their statements recorded before the Court below.
