2. In continuation of the previous orders passed on the earlier dates of hearing, an additional affidavit of the Assistant Director, Education Recruitment Directorate, Department of School Education, Mohali, on behalf of respondent no.1 and 2 (in CWP-24047-2022) has been filed alongwith report of the subject experts from Guru Nanak Dev University in a sealed cover, which on the directions of the Court, has been opened by the Court Master. The report has been examined and answers to as many as 85 questions of the five different streams have been examined by the subject experts while giving the report. As per the

report, necessary steps are required to be taken by the competent authority.

3. Sh.Sunil Kumar Nehra, Advocate has entered appearance on behalf of respondent no.4 (in CWP-24855-2022) and filed his reply, which is taken on record.

4. Let the report submitted by the expert committee be considered by the Principal Secretary, Department of Education, Punjab and thereafter, an appropriate decision, in accordance with law, be taken, within a period of three weeks, from today, positively.

5. Report of the experts, in original, has been returned to the learned State counsel, while placing a photocopy of the same on the record. Learned State counsel has assured the Court that the necessary steps in this regard shall be taken within a period of three weeks, from today.

6. With these observations, the writ petitions are disposed of.

7. All the pending miscellaneous applications, if any, are also disposed of.
