1. Learned counsel for the petitioner submits that keeping in view the order passed by this Court, an order has been passed on 12.12.2023 by the Commission informing the petitioner that in case his candidature is considered in the category of BCA only and not ESM, then also he will to not qualify the subject knowledge test. The said order needs to be challenged by the petitioner by filing appropriate petition, hence, the present writ petition may kindly be disposed of having been not pressed any further with liberty to the petitioner to file a fresh one challenging the order dated 12.12.2023.

2. Learned counsel for the petitioner further submits that as no detail has been given in the order dated 12.12.2023 as to on what account the petitioner does not qualify the subject knowledge test in case treated to be a candidate in the category of BCA, the petitioner intends to file a representation seeking the details of the last selected candidate, who cleared the subject knowledge test, the respondents may kindly be directed to decide the said representation by passing appropriate speaking order.
