In pursuance to order passed by this Court on 11.11.2022, the report
of the Child Welfare Committee, Ludhiana has been received which reads thus:-

“In compliance of the orders paseed by Punjab & Haryana High Court on 11.11.2022 Child Gyatri Dhawan (Age 17 yr approx As per Aadhar Card DOB 2005) D/O Rakesh Kumar (Father) R/O HNO 4174, St. No-3, Ward No-18, Shivaji Nagar, Ludhiana, Ph. No-9780674916 was produced by HC Amarjit Singh, PS Div No-03, Ludhiana, Ph No-9815473787 vide DDR No-38 dated 11.11.2022, and had been ordered to be placed in an Shri Bala Ji Prem Ashram, Ludhiana issued by the Child Welfare Committee Ludhiana under section 37 of the Juvenile Justice (Care and Protection of Children) Act 2015, Act 2015, for a term of short stay on the 11.11.2022. On dated 15.11.2022 application received from father of the child Gyatri Dhawan in which he gave his consent in written to take care of the Child Gyatri Dhawan for her restoration and CWC, Ludhiana also received written consent of child Gyatri Dhawan Child Gyatri Dhawan said that she wants to go with her family as per the version of family and child Gyatri Dhawan Child Welfare Committee, Ludhiana issued restoration order for the girl child Gyatri

Dhawan for her best interest.

But later on at 03:31 PM Supdtt, Shri Bala Ji Prem Ashram, telephonically informed CWC Member Sangeeta that Gyatri Dhawan refused to go along with her father. Hence, this restoration order has been cancelled. Now the child Gyatri Dhawan is living in Shri Bala Ji Prem Ashram, Ludhiana as the previous Placement Order No-4784 dated 11.11.2022 issued by Child Welfare Committee, Ludhiana for the best interest of the child Gyatri Dhawan.”

In view of which, present petition has been rendered infructuous and the same is disposed of accordingly.
