In compliance of the order passed by this Court, report of the Child Welfare Committee, Jalandhar has been received, which reads thus:-

“Pursuant to above mentioned judgement by Hon'ble Mr Justice Aman Chaudhary, shelter to Ms Komalpreet Kaur, aged 17 years and 11 Months(DOB: 29-01-2005 as mentioned in Matriculation Certificate) d/o Late Balwinder Singh r/o Village Bhode,PS Bilga, Jalandhar Rural, Punjab was granted by the undersigned in Children Home, Gandhi Vanita Ashram, Kapurthala Road, Jalandhar on 28-12-2022. In deference to directions issued by Hon'ble Mr Justice Aman Chaudhary vide no VII, counselling report (Annexure-1) and SIR by CPO(IC), DCPU, Jalandhar (Annexure-2) supporting compliance of said directions have been dispatched to Hon'ble Mr Justice Aman Chaudhary vide registered post on 05-01-2023.

It is in response to letter by Superintendent, Children Home, Gandhi Vanita Ashram, Kapurthala Road, Jalandhar vider no.1054 dated 10-01-2023 (Annexure-1) wherein desire expressed by Ms Komalpreet Kaur to go back with her mother and similar wish by Ms Ranjeet Kaur (Mother) to take her along with an undertaking to keep her daughter with love and affection was brought to notice of the undersigned. As a consequence, counselling of Komalpreet Kaur by CPO(IC), DCPU, Jalandhar was solicited by the undersigned (Annexure-

2) with a view to verifying wish of Komalpreet Kaur. Perusal of said report was explored by the undersigned and decision to restore Ms. Komalpreet Kaur to her mother was taken while complying with norms and procedures as practised by the undersigned. [Annexure-3:Form 44 read with Rule 82(1) and Form 20 read with Rule 18(8) and 19(7) of Juvenile Justice Act, 2015 and Model Rules, 2016]”

In view of the above, present petition stands disposed of.
