The instant petition has been filed under Section 482 of Cr.P.C. seeking appropriate directions to respondent No. 1 and 2 to transfer the investigation of the case FIR No. 20 dated 08.02.2018, under Sections 420, 419, 411, 473, 471, 465, 468, 379, 120-B, 506 and 170 IPC, registered at Police Station Fatehgarh Churian, Police, District Batala to some independent investigating agency.

In pursuance to the issuance of notice of motion, reply by way of affidavit dated 04.03.2020 of Mr. Balbir Singh, PPS, Deputy Superintendent of Police, Sub Division Fatehgarh Churian, Police Station Batala, has been filed on behalf of respondent nos.1 to 4 and in para no.6 thereof it has been stated that after conducting the investigation impartially

and in a fair manner, *challan* under Section 173 Cr.P.C. has been prepared and presented before the Court of learned Judicial Magistrate Ist Class/ Illaqa Magistrate, Batala on 18.02.2020. Learned State counsel further submits that the charges have been framed on 03.08.2022 and now the case is fixed for prosecution evidence for today i.e. 01.03.2023 and out of 19 witnesses, 06 witnesses have been examined. It has further been submitted that three cases have been registered against Jaspal Singh S/o Salwinder Singh (petitioner), which are given as under:-

1. FIR No. 206 dated 18.10.2014, under Section\_\_ of NDPS Act, Police Station Kambo, District Amritsar (Rural);
2. FIR No. 136 dated 28.09.2017 under Sections 379-B, 506, 34 IPC, Police Station Kambo, District Amritsar (Rural);
3. FIR No. 72 dated 16.03.2017 under Sections 307, 324, 323, 148, 149 IPC and Sections 25/27-A Act, police Station Amritsar Sadar, District Amritsar (Rural).

In view of the above, the instant petition is rendered infructuous and the same is disposed of, accordingly.
