Present writ petition has been filed for quashing the impugned letter dated 01.03.2023 (Annexure P-30) passed by respondent No.4, impugned letter dated 02.01.2023 (Annexure P-26) passed by respondent No.5 and impugned letter No.3036 dated 23.12.2022 (Annexure P-24) passed by respondent No.6, inter alia on the ground that the genuine and legitimate claim of the petitioner has been rejected by the respondents only on account of the fact that the matter is complex. Further prayer has been made for directing the official respondents to consider and adjudicate upon the genuine and legitimate claim of the petitioner and to decide the representation of the petitioner after due consideration of the entire revenue records of the land in question and for directing the respondents to correct the revenue entries pertaining to the Khasra No.364/336 (2B-7B) in Jamabandis for the year 2006-07 (Annexure P-11) till 2021-22 (Annexure

P-12) whereby the same has been wrongly and erroneously recorded in favour of respondent No.8, even though the said land has never been acquired by the State.

Learned senior counsel for the petitioner has submitted before this Court that the petitioner has raised his grievance before respondent No.6-Tehsildar, Panchkula number of times but the same has not been taken into consideration. He further submits that finally one representation dated 31.07.2023 (Annexure P-33) has already been filed by the petitioner and the same has not been decided till date. He submits that he will be satisfied if a direction is issued to respondent No.6-Tehsildar, Panchkula to decide the same in a time bound manner.

Notice of motion to the official respondents at this stage.

On asking of the Court, Ms. Upasna Dhawan, AAG, Haryana appears and accepts notice on behalf of the official respondents.

In view of the above position, the present petition stands disposed of with a direction to respondent No.6-Tehsildar, Panchkula to look into the representation of the petitioner dated 31.07.2023 (Annexure P-33) and decide the same in accordance with law within a period of eight weeks from today.
