**CM-1567-CWP-2023 in/and CWP-32980-2019 (O&M)**

This is an application filed under Section 151 of CPC for withdrawal of the main writ petition.

Learned counsel for the applicant/petitioner has submitted that the prayer in the main Civil Writ Petition is for quashing of order dated 25.06.2019 (Annexure P-12) passed by the Financial Commissioner, Haryana, order dated 01.06.2016 (Annexure P-11) passed by the Commissioner, Rohtak Division, Rohtak and order dated 28.10.2015 passed by the Collector-cum-DRO, Rohtak as well as order dated 17.04.2015 passed by the Assistant Collector, Ist Grade, Rohtak, vide which, the

objections raised by the petitioner regarding the partition of the suit land had been dismissed.

Learned counsel for the petitioner has submitted that since the matter has been compromised, thus, he seeks permission of this Court to withdraw the main writ petition and also prays that the date of hearing in the main writ petition which is now listed for 10.03.2023 be preponed to today for final disposal.

On the other hand, learned counsel for the State has submitted that in view of the fact that the petitioner is withdrawing the main writ petition, thus, he has no objection in case the date of hearing in the main case is preponed from 10.03.2023 to today itself for final disposal.

Keeping in view the abovesaid facts and circumstances, the present application bearing No.CM-1567-CWP-2023 is allowed and the date of hearing in the main case is preponed from 10.03.2023 to today and the same is taken on Board today itself for final disposal.

Accordingly, the main Civil Writ Petition bearing No.CWP-32980-2019 is dismissed as withdrawn.

All the pending miscellaneous applications, if any, shall stand disposed of in view of the abovesaid order.
