1. On 17.10.2023, the following order was passed by this Court:-

“By way of present petition filed under Section 438 Cr.P.C., petitioner prays for grant of anticipatory bail in case FIR No.92 dated 11.07.2023 registered under Sections 452, 323, 34 IPC (Section 325 IPC added later on) at Police Station Vairo Ke, District Fazilka.

It is contended by learned counsel for the petitioner that though the occurrence took place on 02.07.2023 but the FIR has been lodged on 11.07.2023 after delay of 9 days which is unexplained. Learned counsel further submits that only allegations against the petitioner is that she along with Jyoti, Prince and Nanu came to the house of the complainant and Preeto (present petition) caught hold the complainant of his right arm and hit his arm with the door. Learned counsel also submits that in fact complainant had fallen from a tree while picking the jamun fruit.

Notice of motion.

Mr. R.S. Khaira, DAG, Punjab, accepts notice on behalf of the

respondent- State. Copy of the petition be supplied to him during course of the day.

Adjourned to 07.12.2023 for filing status report.

To be heard along with CRM-M-51531 of 2023.

In the meantime, in case of her arrest, the petitioner shall be released on interim bail subject to the satisfaction of the Arresting Officer/ Investigating Officer. However, it is further directed that the petitioner shall join the investigation as and when so required by the Investigating Officer. She shall not contact any person associated with the case to dissuade her from the investigation in any manner whatsoever and nor shall leave the country without prior permission of the Court. She shall further comply with the conditions stipulated in Section 438(2) Cr.P.C.”

2. Today, on instructions from ASI Chander Shekhar, learned State counsel has informed this Court that the petitioner has joined the investigation, in compliance of the order dated 17.10.2023 and is no longer required for further investigation.

3. In view of the aforesaid, the order dated 17.10.2023 whereby the petitioner was granted interim anticipatory bail, is hereby made absolute.

4. However, she shall continue to join investigation, if and so required by the Investigating Officer.
