1. Petitioners by way of present petition claim to be living in relationship and have invoked writ jurisdiction of this Court seeking protection of their life and liberty.
2. Reply by way of affidavit of Rajesh Kumar, HPS, Deputy Superintendent of Police, Yamuna Nagar on behalf of the respondents-State has been filed. The same is taken on record. The operative part thereof reads as under:-

“2. That after receipt of notice in present petition, the same was marked to SI Subhash Chand of P.S. Gandhi Nagar. In compliance of the same SI Subhash Chand went at the address of petitioners which is mentioned in the petition. At the said address, petitioners were found present and they got recorded their statements. The petitioner no.1 stated that she is married with respondent no. 4- Ashwani Kumar but he used to beat him and he shunted her out from the house. Now she is residing living-in-relationship with petitioner no. 2 (Parbhat Kumar). Now they have no threat at the hands

of respondent no. 4. The true translated copy of statement of petitioner no. 1 is enclosed herewith as **Annexure R-1**. The petitioner no. 2 stated he is residing living-in-relationship with petitioner No.1 and now he has no threat. The true translated copy of statement of petitioner no.2 is enclosed herewith as Annexure R-2.

3. That the petitioner no. 1 provided Mobile No.8859278736 of respondent no. 4. On this, SI Subhash Chand contacted the respondent no. 4 as aforesaid mobile No. 8859278736. On this respondent no.4 told that he has filed a petition for divorce which is pending adjudication before the Hon'ble Court at Saharanpur which is pending adjudication for 16-12-2023 and in this regard, he will send his affidavit through WhatsApp. In this regard, a GD Report No. 014, dt. 22-11-2023 was recorded at Police station Gandhi Nagar, Yamuna Nagar. The true translated copy of GD Report No. 014, dt. 22-11-2023 is enclosed herewith as **Annexure R-3**. The respondent no. 4 Ashwani Kumar also sent his affidavit through WhatsApp. The photocopy of affidavit of respondent no. 4 is enclosed herewith as **Annexure R-4.**”

3. Learned State counsel submits that as per the statements recorded by the parties as on date, none of the petitioners has any threat perception and in case they represent again fearing any threat, the same shall be dealt in accordance with law.
4. Consequently, the present petition is disposed off accordingly.
