The instant petition under Section 482 of Cr.P.C. has been preferred by the petitioner for issuance of directions to the official respondents to conclude the investigation in case FIR No.128 dated 01.04.2023, registered under Sections 148, 149, 323, 452, 307, 325 and 506 of IPC, at P.S. Hathin, District Palwal (Annexure P-1) and to decide the representation dated 04.10.2023 (Annexure P-4) preferred by the petitioner in an expeditious manner.

2. It is, *inter alia*, contended by learned counsel for the petitioner that the petitioner had got registered the aforesaid FIR on 01.04.2023 (Annexure P-1), but till date no action thereon has been taken by the police. Learned counsel for the petitioner further contends that the petitioner has already moved the representation dated 04.10.2023 (Annexure P-4) to respondent No.3- Inspector General of Police, Rewari, South Range, Rewari, Haryana, but no action thereon has been taken. Learned counsel for the petitioner further submits that for the purpose of the petition, the

petitioner will be satisfied if appropriate directions are given to respondent No.3- Inspector General of Police, Rewari, South Range, Rewari, Haryana, to consider and dispose of the representation (Annexure P-4) dated 04.10.2023 in accordance with law in an expeditious manner.

3. Notice of motion.

4. On the asking of the Court, Ms. Gaganpreet Kaur, DAG, Haryana, who is present in Court, accepts notice on behalf of the respondents-State.

5. After hearing the respective submissions and also the averments made in the petition by learned counsel for the petitioner, without commenting on the purpose of the case, the present petition is disposed of with a direction to respondent No.3- Inspector General of Police, Rewari, South Range, Rewari, Haryana, to consider and dispose of the representation dated 04.10.2023 (Annexure P-4) moved by the petitioner in accordance with law in an expeditious manner and the decision so taken be also intimated to the petitioner as well.

6. Disposed of.

7. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
