1. By this common order, above mentioned fourteen writ petitions are being disposed of as all the writ petitions involve the same question of law and similar facts.

2. In the present petitions, the claim of the petitioners is that they are not being granted the overtime allowance though, they are entitled for the same keeping in view the settled principle of law settled by this Court while passing order in CWP No. 3005 of 2018 titled as Brij Bhushan and others Vs. State of Haryana and others, decided on 01.02.2019.

3. On being asked, as to on which date, the petitioners had rendered overtime service so as to get the said allowance, learned counsel for the petitioners submits that no detail has been mentioned in the petition but the same can be furnished to the respondents by filing an appropriate representation.

4. Learned State counsel submits that in case, any representation is received from the petitioners giving the details of the period for which the petitioners had discharged the over time duties, the same will be looked into and verified from the record and in case, the said claim is found to be genuine, the benefit of overtime allowance will be granted to the petitioner(s) within a period of eight weeks of the receipt of any such representation, if not already made or petitioners have not been provided with rest day to compensate overtime.

5. Learned counsel for the petitioners submits that keeping in view the said statement of learned counsel for the respondents, the present petitions may kindly be disposed of having been not pressed any further with

liberty to the petitioners to file appropriate representation before the authorities concerned.

- 6. Ordered accordingly.
- 7. Miscellaneous application pending, if any, also stands disposed of.
