KULDEEP TIWARI. J.(Oral)

1. In compliance of the last order, a status report by way of affidavit dated 01.12.2023, of Sh. Amarjit Singh, SI/SHO, Police Station Sadar Jagraon, District Ludhiana (Rural), has been filed on behalf of respondents No.1 to 3-State in the Court today. The relevant extract of the same, reads as under:-

“4. That SI Surjit Singh also recorded the statement of petitioner Ramandeep Kaur. She stated that she has solemnized marriage with Kuldeep Singh son of Hari Singh r/o Ramgarh about 12 years back. Three children are born from this wedlock. There developed dispute between both of them after 12 years. When she used to attend her work, she has started talking with Gurpreet Singh son of Balvir Singh r/o Wazidke Khurd. Now they are living in relations for the last about 2 months. They have filed one petition and has apprehension of danger to their lives from their relatives, father Gurpreet Singh, first husband Kuldeep Singh. At present she and Gurpreet Singh both are residing at village Wazidke Khurd PS Thulliwal District Barnala. Her one son Lakhwinder Singh out of 3 children are residing with her. If they feel any danger to themselves in future they will lodge report with their police station Thuliwal or they will brought the matter to the notice of Senior Officers at Barnala. For the time being they have no danger to their lives from anybody. They also do not want to take any protection. True Translation copy of statement of Ramandeep Kaur is enclosed as Annexure R-2/T.

5. That SI Surjit Singh also contracted the private respondents and recorded statements of Gurpreet Singh s/o Ranjha Singh, Hari Singh s/o Inder Singh, Kuldeep Singh s/o Hari Singh. These persons have stated that they have no concern with Ramandeep Kaur now and she may live where she wants to live.

6. That SI Surjit Singh has submitted his report dated 27-11- 2023. SI Surjit Singh has stated that as per statements of both the petitioners they have no danger to their lives from anybody. If they feel any danger to their lives then they will inform the police of PS Thulliwal.”

2. Considering the specific averment made in the status report that there is no threat perception to the life and liberty of the petitioners, at this stage, no further action is required and accordingly the instant petition is rendered infructuous.
3. Dismissed as having been rendered infructuous.
