The petitioner is seeking emergency parole for four weeks as the marriage of his daughter namely Deesh Kaur is to take place on 10.12.2023.

2. Learned counsel for the petitioner submits that the petitioner has been convicted under Sections 6 of the POCSO Act, 376 and 506 IPC in FIR No.111 dated 29.06.2021, registered at Police Station Ladhuwal, District Ludhiana and sentenced to undergo rigorous imprisonment for a period of 20 years and to pay fine of Rs.1,00,000/- and in default of payment of fine to further undergo rigorous imprisonment for 06 months. He has undergone an actual sentence of over 02 years and 05 months. The marriage of his daughter is to take place on 10.12.2023. He also submits that presence of the petitioner would be necessary to perform ceremonies in connection with the marriage of his daughter.

3. Leaned State counsel on instructions from SHO, Sidhwan Bet, District Ludhiana states that the marriage of the daughter of the petitioner is to take place on 10.12.2023 at Village Akkuwal, Tehsil Jagraon, District Ludhiana and has filed the report which is taken on record.

4. Heard.

5. The marriage of the daughter of the petitioner is to take place on 10.12.2023. His presence would be necessary to perform ceremonies in connection with the marriage. Consequently, the petition is allowed and the petitioner shall be granted parole for a period of 03 weeks subject to his furnishing necessary surety bonds to the satisfaction of the competent authority. The petitioner shall be released on 05.12.2023 and he shall surrender before the concerned Jail on 26.12.2023 by 05:00 p.m. i.e after expiry of period of 03 weeks from the date of his release on parole.

6. At the time of his release, the SHO of concerned Police Station shall be informed. The petitioner shall furnish his mobile number to the SHO and keep location of his phone on during the period of parole. He would not make any endeavour to harass or cause any harm to the victim or her family member.

7. Pending application(s), if any, also stands disposed of.
