MAHABIR SINGH SINDHU, J.

Present petition has been filed under Section 438 of the Code of Criminal Procedure, 1973 for grant of pre-arrest bail to the petitioners in FIR No.164 dated 15.09.2023 (P-1), under Sections 307, 323, 324, 148 read with Section 149 of the Indian Penal Code, 1860, registered at Police Station, City Budhlada, District Mansa.

(2) Above case was registered on the basis of statement made by complainant-Nisha Rani with the allegations that petitioners, who were members of unlawful assembly, caused several injuries upon the complainant party with *Daangs*, Sticks, *Kirpans* & Iron Rods.

(3) This Court, while issuing notice of motion on 18.12.2023, granted interim bail to petitioners and the same reads as under:-

“Contends that it is a version and cross-version case; injuries alleged are simple in nature and co-accused with similar allegations has already been granted concession of interim pre-arrest bail vide order dated 03.11.2023 passed in CRM-M-55049-2023.

Notice of motion.

Mr. C.L.Pawar, Additional Advocate General, Punjab, accepts notice on behalf of the respondent-State and seeks time to have instructions and/or file written response in the matter.

Posted for 20.12.2023.

To be heard along with CRM-M-55049-2023

In the meanwhile, petitioners shall join investigation before the Investigating Officer. In the event of their arrest, the Arresting Officer would admit them to interim bail, till the next date of hearing, on furnishing adequate bail and surety bonds to his satisfaction. The petitioners shall also abide by all the conditions as envisaged under Section 438(2) of the Code of Criminal Procedure, 1973.”

(4) Learned Counsel submits that in pursuance of the aforesaid order, petitioners have already joined the investigation and their custodial interrogation is not required.

(5) Learned State Counsel, on instructions from HC Gurwinder Singh, submits that petitioners have joined investigation and as on today, their custodial interrogation is not required.

(6) In view of above, interim order dated 18.12.2023 is made absolute subject to the conditions as envisaged under Section 438(2) Cr.P.C.

(7) It is also made clear that petitioners shall fully co-operate with the Investigating Officer as and when called for further investigation.

- (8) The above observations may not be construed as an expression of opinion on merits of the case; rather confined only to decide the present bail matter.
- (9) Disposed off accordingly.
- (10) Pending application(s), if any, shall also stand disposed off.
