Prayer in this 2nd petition filed under Section 439 Cr.P.C., is for grant of regular bail to the petitioner in FIR No.0114 dated 12.06.2021 registered under Sections 21 of the NDPS Act (Section 29 of the NDPS Act added later), at Police Station Haryana, District Hoshiarpur.

In Para 11 of the petition, it has been stated that except 04 cases i.e. FIR No.61 dated 26.02.2019 u/s 22 of NDPS Act, 1985, Police Station Model Town, District Hoshiarpur, FIR No.224 dated 23.10.2015 u/s 21 of NDPS Act, 1985, Police Station Model Town, District Hoshiarpur, FIR No.11 dated 02.02.2015 u/s 22 of NDPS Act, 1985, Police Station Adampur, District Hoshiarpur and FIR No.239 dated 12.08.2019 u/s 18 of NDPS Act, 1985, Police Station Model Town, District Hoshiarpur, the petitioner is not involved in any other case.

On the other hand, counsel for the State has filed the Custody Certificate today in the Court, which is taken on record.

A perusal of the Custody Certificate, would show that apart from the aforesaid 04 cases/FIR, the petitioner is involved in other cases also. The particulars of the said cases are reproduced as under:-
