The instant petition has been preferred by the petitioner seeking issuance of an appropriate writ in the nature of Mandamus directing the respondents to make the due payment of Rs.1,05,55,571/- including security qua the work of Construction of Govt. College at Village Fatehgarh Karotana, District Moga (Punjab), executed by the petitioner along with interest @ 12% per annum.

Learned counsel for the petitioner contends that the work of Construction of Govt. College at Village Fatehgarh Karotana, District Moga (Punjab), was allotted to the petitioner vide E.E. No.150 dated 29.05.2019 (Annexure P-1) and subsequently the period to execute the work was extended vide letter No.643 dated 12.05.2023 (Annexure P-2). He submits that the aforesaid work stands successfully executed, however, the payment against the execution of the aforesaid work has not been released yet, even though the final bills submitted by the petitioner already stand approved by

the competent authority. He contends that in this regard, a legal notice dated 24.11.2023 (Annexure P-5) has been sent by the petitioner and that despite a lapse of about one month since the date of the legal notice neither any decision has been taken thereupon nor has the due and undisputed payment been released by the respondents. He further contends that he would be satisfied in case the respondent-authorities are directed to look into the legal notice and the grievance espoused by the petitioner therein and a speaking order is passed thereupon in accordance with law and in a time bound manner.

Notice of motion.

On the asking of the Court, Ms. Niharika Sharma, AAG, Punjab, who is present in Court, accepts notice on behalf of the respondents and she has no objection to the aforesaid prayer being granted.

Accordingly, with the consent of the parties and without commenting upon the merits of the case, the present petition is disposed of and the respondent No.4-the Executive Engineer, Construction Division, PWD B & R Branch, Moga, is directed to take note of the legal notice dated 24.11.2023 (Annexure P-5) sent by the petitioner and to pass a reasoned and speaking order thereupon in accordance with law and preferably within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that in the event the entitlement of the petitioner being established as per law, the payment due to the petitioner shall be released expeditiously and preferably within a further period of three months.

Petition stands disposed of accordingly.
