The present petition under Section 482 Cr.P.C. has been preferred by the petitioner seeking directions to the official respondents No.2 and 3 to arrest the accused and to present the challan in case FIR No.109 dated 03.09.2015 under Section 406, 420 and 120-B of IPC registered at P.S. Zirakpur, SAS Nagar Mohali, (Punjab) (Annexure P-1).

2. It is, *inter alia*, contended by learned counsel for the petitioner that the petitioner had got registered FIR (Annexure P-1) way back in 2016. There was a compromise between the petitioner and one of the accused on the basis of which quashing petition was preferred in this Court vide CRM-M-29535-2016 titled "*Kavita Bajaj Versus State of Punjab and another*" but the same was declined vide order dated 05.10.2016 (Annexure P-6). He submits that the police has not taken any action to apprehend the accused and to present the challan after thorough investigation and in this regard, the petitioner has moved representation dated 04.12.2023 (Annexure P-7) to respondent No.2- The Senior Superintendent of Police, SAS Nagar,

Mohali (Punjab), but no action thereon has been taken. He submits that for the purpose of the petition, the petitioner will be satisfied if appropriate directions are given to respondent No.2 - The Senior Superintendent of Police, SAS Nagar, Mohali (Punjab), to consider and dispose of the representation (Annexure P-7) in accordance with law in an expeditious manner.

3. Notice of motion.

4. On the asking of the Court, Mr. Subhash Godara, Addl. A.G., Punjab, who is present in Court, accepts notice on behalf of the respondents-State.

5. Heard.

6. After considering the respective submissions and considering the averments made in the petition, without commenting on the merits thereof, the present petition is, hereby, disposed of with direction to respondent No.2- The Senior Superintendent of Police, SAS Nagar, Mohali (Punjab), to consider and dispose of the representation (Annexure P-7) in accordance with law in an expeditious manner.

7. The decision so taken be intimated to the petitioner.
