The present petition under Section 482 Cr.P.C. has been preferred by the petitioner seeking directions to the official respondents No.2 and 3 to conduct fair and impartial investigation in consonance with the provisions of Section 154, 156 to 159 of Cr.P.C. in case DDR No.002 dated 14.11.2023 registered at P.S. Sudhar, District Ludhiana, in accordance with law.

2. It is, *inter alia*, contended by learned counsel for the petitioner that the petitioner, being aggrieved by the acts and conducts of respondents No.6 and 10, had lodged a DDR No.002 (Annexure P-4) on 14.11.2023, but till date no action thereon has been taken and even respondent No.5 has been illegally pressurizing him to effect compromise with the private respondents and aggrieved by the same, the petitioner had moved the representation

(Annexure P-5) dated 25.11.2023 to respondent No.3- Senior Superintendent of Police, Jagraon, District Ludhiana (Rural), but till date, no action thereon has been taken. He further submits that for the purpose of the petition, the petitioner will be satisfied if appropriate directions are given to respondent No. 3 - Senior Superintendent of Police, Jagraon Ludhiana Rural, to consider and dispose of the representation dated 25.11.2023 (Annexure P-5) in accordance with law in an expeditious manner.

3. Notice of motion to official respondents.
4. On the asking of the Court, Mr. Subhash Godara, Addl. A.G., Punjab, who is present in Court, accepts notice on behalf of the respondents No.1 to 4-State.
5. Heard.
6. After considering the respective submissions and considering the averments made in the petition, without commenting on the merits thereof, the present petition is, hereby, disposed of with direction to respondent No.3- Senior Superintendent of Police, Jagraon, District Ludhiana (Rural), to consider and dispose of the representation (Annexure P-5) in accordance with law in an expeditious manner.
7. The decision so taken be intimated to the petitioner.
8. Disposed of.
