- 2 07-10-2024 1. Mr. Chakrapani, learned counsel appearing on behalf of the petitioners, submits that the present case is fully covered by the judgment and order, dated 29.08.2024, passed by this Court in CWJC No. 19683 of 2018 and analogous case.
